NARRATIVE: On 06/15/18 at approximately 1511 hours, Dep. D. Johnson and I (Dep. Chambers) were dispatched to the listed location in regards to a domestic dispute.

While en-route, Central Dispatch advised that [REDACTED] had left the residence with [REDACTED] and would be waiting in a [REDACTED] off of [REDACTED]

I contacted [REDACTED] in the [REDACTED] while Dep. Johnson made contact with [REDACTED] at the [REDACTED]

I asked [REDACTED] what was going on and [REDACTED] told me the following: [REDACTED] and [REDACTED] are in the process of [REDACTED] and [REDACTED] has not [REDACTED] for a [REDACTED] [REDACTED] said [REDACTED] was scheduled to pick up [REDACTED] but instead showed up at [REDACTED] [REDACTED] said since [REDACTED] has not been [REDACTED] was under the assumption that [REDACTED] did not have to let [REDACTED] in and admitted to standing in the doorway refusing to let [REDACTED] inside.

[REDACTED] said [REDACTED] eventually forced [REDACTED] way past [REDACTED] and then proceeded to tell [REDACTED] that [REDACTED] was staying the night there and that it was [REDACTED] house too. [REDACTED] said [REDACTED] took [REDACTED] and placed [REDACTED] and proceeded out the garage. [REDACTED] said [REDACTED] followed [REDACTED] outside and ran in from of the car multiple times, forcing [REDACTED] to stop and re route. [REDACTED] said [REDACTED] was finally able to make it off the property and drove the [REDACTED] where we met.

[REDACTED] told me multiple times that there was nothing physical that occurred during the incident and denied ever touching [REDACTED].

[REDACTED] also mentioned [REDACTED] including [REDACTED] with [REDACTED] and a [REDACTED] none which have been [REDACTED] I tried to explain to [REDACTED] that since [REDACTED] is still [REDACTED] that [REDACTED] still has access to the residence and since there is no [REDACTED] also does not need to necessarily [REDACTED]

I called and spoke to Dep. Johnson who had been talking to [REDACTED] and [REDACTED] Dep. Johnson informed me that [REDACTED] had been [REDACTED]

I told Dep. Johnson what [REDACTED] had told me and he advised that [REDACTED] had a similar story. Dep. Johnson told me that [REDACTED] advised that there had been a struggle in the garage when [REDACTED] attempted to [REDACTED] [REDACTED] said that as [REDACTED] was trying to [REDACTED] and then [REDACTED] down. [REDACTED]

said [REDACTED] then started to drive off at which time [REDACTED] stood in front of the vehicle multiple times in an attempt to have [REDACTED] stop the vehicle.

Dep. Johnson advised me that [REDACTED] was holding an [REDACTED] and that [REDACTED] but that there was [REDACTED]

I re-contacted [REDACTED] and asked [REDACTED] about the struggle in the garage which [REDACTED] left out of [REDACTED] story the first time I talked to [REDACTED] admitted to me that [REDACTED] and [REDACTED] were both pulling on [REDACTED] but that eventually [REDACTED] let go. [REDACTED] denied ever [REDACTED] or [REDACTED] and said [REDACTED]

With [REDACTED] permission I talked to [REDACTED] and [REDACTED] told me that both [REDACTED] and [REDACTED] were grabbing [REDACTED] arm but said [REDACTED] did not ever see [REDACTED] nor did [REDACTED] see [REDACTED]

Based on [REDACTED] statements and apparent [REDACTED] I advised [REDACTED] that [REDACTED] was being charged with violation of I.C. 18-918 Domestic Battery and issued [REDACTED] a citation (#174563).
